application as prayed;

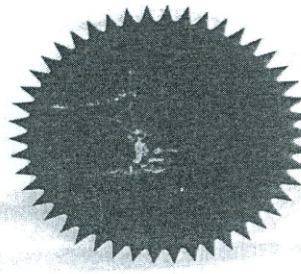
