or Ibrahim Magu, the acting Chairman of the Economic and Financial Crimes Commission, EFCC, the 11th day of the 11th month (November) in 2015 will forever remain a memorable one etched on his mind as historic.

That day witnessed yet another change in the mantle of leadership of Nigeria's foremost anti-graft agency, as Magu took over from Ibrahim Lamorde.

Appearing smart and trim, Magu described his emergence as "a call to duty".

"I am today faced with mixed feelings. I have that instinctive happiness for being the one chosen among an array of senior colleagues and competent contemporaries," he said. "I also feel heavy around my shoulders, the burden of leadership and expectations."

Asserting his readiness to succeed in running the affairs of the EFCC, Magu, who like Lamorde is a pioneer staff of the agency, expressed absolute commitment to executing the war against corruption.

He paid tribute to the "founding fathers" of the agency, adding that: "I want to state our resolve not to falter on the well-established tradition of patriotism, dedication, courage and fearlessness, and we will take this responsibility with utmost seriousness that it deserves."

He promised to "ginger up the anti-corruption campaign", noting that there was no better time to do so than now.

Corruption, according to Magu, inhibits any meaningful development in the society, as such, must be fought to a standstill.

"There is the need to make sure that whatever is gotten for common use did not end up in private pockets," he said, stressing that fighting corruption to a standstill will make the country attractive to foreign investors.

Magu pledged to be a listening and responsive leader, who will give priority to welfare and capacity development of staff.

"I am ready and willing to work with everybody without any primordial concerns," he said.

Noted as a no-nonsense investigator, Magu said, "While we will intensify on our work out there, we will also keep an eye internally, and will not tolerate indiscipline nor condone abuse of office or acts of corruption."

He commended Lamorde for his leadership and wished him the best in his future endeavours. He also commended the



management of the agency for having worked assiduously to ensure the sustenance of the objectives of establishing the EFCC.

Lamorde described Magu as a "brother, colleague and friend", and urged management staff to give him all the necessary support to ensure that he succeeds in the discharge of his duty. Lamorde took over from Farida Waziri as Acting Chairman on November 28, 2011. He was on November 9, 2015 asked to proceed on terminal leave by President Muhammadu Buhari, ahead of the end of his tenure on February 15, 2016.

The handover ceremony was witnessed by the Secretary to the Commission, Emmanuel Aremo, as well as directors and heads of the agency's units.



brahim Magu, the acting Chairman of the Economic and Financial Crimes Commission, EFCC, is known in the anti-graft circles as "the General". It is an appellation he earned by dint of hard work, selfless service to humanity and unalloyed commitment to the fight against corruption.

A pioneer staff of the agency, Magu, is no stranger to the operations, philosophy, ideals and objectives of the EFCC.

His slim physique and simple carriage rarely gives him away as a "no nonsense" investigator that he is. Yet, his emergence as the new anti-graft czar in town has filled the Nigerian elite who have soiled their hands in shady deals, with dread.

His verve to see to the end of the trial of any case earned him respect and friends, but also more enemies in the circles of the Nigerian elite. His service with the EFCC was interrupted in 2008 when he was redeployed to the Nigeria Police by Farida Waziri, who replaced Nuhu Ribadu as chairman. The emergence of Ibrahim Lamorde, who took over from Waziri, however saw Magu being brought back to the EFCC in recognition of his professionalism.

At the maiden rewards and recognition ceremony of the EFCC, which held in December last year, Magu received a Noteworthy Achievements award for being "a courageous and diligent investigator who contributed immensely to a good number of high profile cases, which saw for the first time ever in the history of Nigeria, high ranking and serving officials brought to book for their commission of economic and financial crimes".

His emergence as the new anti-graft czar in town has no doubt filled the Nigerian elite who have soiled their hands in shady deals, with dread.

Currently an Assistant Commissioner of Police, Magu has taken up several leadership positions within and outside of the EFCC.

He served as the head of the agency's Economic Governance Unit - the unit tasked with investigating corruption cases involving Politically Exposed Persons, PEPs, in the society. He was the Deputy Director at the EFCC's Department of Internal Affairs - the unit entrusted with the task of ensuring discipline and zero tolerance to corruption among staff of the Commission.

Anative of Maiduguri, Borno State, Magu, read Accounting at the University of Maiduguri, and specializes in investigating financial crimes. Skilled in forensic accounting, he also trained at the FBI institute and the London Metropolitan Police institute. He has also served in Bosnia under the United Nations peacekeeping police operation.

Until his appointment, Magu was a member of the 14-man investigative committee set up by President Muhammadu Buhari to probe the procurement of arms in the Armed Forces from 2007 till date.

It has been an eventful year for the EFCC, which this year marked its 12 years of fighting corruption and improving the image of Nigeria in the international community

or the Economic and Financial Crimes Commission, EFCC, the war on corruption was taken to a higher level in 2015 as it once again touched politically exposed persons, PEPs, usually tagged untouchables, with the aim of holding them accountable for their deeds.

Such efforts, also received support from international law enforcement agencies including the Federal Bureau of Investigation, FBI, among others.

As the anti-graft agency prepares for the tasks of 2016, below are a few milestones of 2015.

FEATS

It was a well-deserved recognition of Nigeria's efforts to rid the country of economic and financial crimes as the Nigeria Financial Intelligence Unit, NFIU, early in the year in far away Berlin, Germany, was elected regional head of Western/Central Africa sub-region, The Egmont group is a very highly standardized organization, and emergence of Nigeria as a regional representative for 26 other African Nigeria. The NFIU joined the Egmont

countries was an indication of international confidence in the system in

Group in 2007, but the election as the regional head, confers on the country a new status as a country that is contributing its quota to fighting money laundering, and other financial crimes, including financing of terrorism. The feat gives a positive picture to the international community that Nigeria is not a haven for money launderers or terrorism financing, and that measures are in place to check acts of corruption.

The EFCC Academy located in Karu, Abuja, was this year recognized and designated the training institute of the National Anti-Corruption Institutions in West Africa, NACIWA. It was a feat that took about three years to achieve. It came on the heels of a visit in March by Issoufou Boureima, president, High Authority for the Fight Against Corruption and Similar Crimes, HALCIA, Republic of Benin, who also doubles as the president of NACIWA, who led a delegate to the Academy. In September the Academy hosted the firstever training for officers of anti-graft agencies in the West African sub-region. The feat also spurred a visit by the Kenyan



Ethics and Anti-Corruption Commission, EACC, who embarked on a study visit to the EFCC with the aim of understudying the anti-graft agency's modus operandi. The EACC has also adopted the EFCC



Academy as a model to be replicated in East Africa. The Liberian Anti-Corruption agency has also visited the EFCC with the aim of understudying the modus operandi of the agency.



The EFCC formally launched a website www.efccnigerialibrary.com dedicated to the EFCC Library. The process of creating the platform, which had been long in the pipeline, came to fruition this year. Its purpose is basically to serve as an information outreach not only to staff of the agency, but also the general public. Among other resources, the platform also includes a digital library, links to online materials, as well as notable media platforms in Nigeria. The e-library adopts | financial crimes, law, among others.

a user oriented approach, which allows users to send request to the library, solicit for national and international publishers' catalogs. Other materials available include speeches of former EFCC chairmen and paper presentations, collections from the Academy Research department, newspaper cuttings, policy documents. Its subscription to online resources also forms the foundation for the library, making it a major destination for researchers in areas of economic and

GLOBAL SUPPORTS

In a rare show of support, the United States government assisted the agency by donating modern technology tools to help in the task of combating corruption. Dehab Ghereab, acting US Consul-General to Nigeria, on behalf of the US government, donated a Forensic Recovery of Evidence Device, FRED, to the agency in a bid to support the EFCC's efforts to fight cyber crime, and to standardize its operations. At a five-day inter-agency Cross Border Financial Investigation training programme organized by the United States Department of Homeland Security, which held at the EFCC Academy, Karu, Abuja in August, the US government also donated a high-tech counting machine capable of detecting counterfeit bills in any country's currency.

Two staff of the EFCC were selected to take part in this year's specialized training at the FBI National Academy in Quantico, Virginia, USA. The FBI National Academy established in July 1935, provides professional development course for US and international law enforcement officers, and participants are usually selected by the FBI.

Apparently not wanting to be left out in the show of support for the EFCC, the French government through its representative, Eric Bonnichon, Police Attaché of the Embassy of France, also donated eight laptops for use at the agency's Information and Computer Technology, ICT, unit.



NEW TURFS



In its concerted efforts to rid the Nigerian society of economic and financial crimes, the EFCC introduced a new dimension that now includes drama. It is the first of its kind in the history of law enforcement in the country. The move was to take the agency's sensitization and enlightenment programme beyond the confines of civil society and groups engagements. The idea relates to the preventive mandate of the agency.

As part of engaging the public in the war against corruption, the agency also launched the maiden edition of *Red Alert on Scam*, designed as a guide for the general public, and structured as a resource material, to enlighten them about the various red flags to note as indicators of being scammed. The booklet, a new initiative in the corruption war, is structured to prod members of the public to be proactive, by exposing them to the antics of tricksters.



HIGH PROFILE CASES





Murtala Nyako, a former governor of Adamawa State, his son, Senator Abdul-Aziz Nyako, Abubakar Aliyu and Zulkifikk Abba were in July arraigned before Justice E. Chukwu of the Federal High Court sitting in Abuja on a 37-count charge bordering on criminal conspiracy, stealing, abuse of office and money laundering to the tune of N29 billion. The accused persons are alleged to have, at various times between 2011 and 2013, used five companies - Blue Opal Nigeria limited, Serore Farms & Extension Limited, Pagoda Fortunes Limited, Towers Assets Management Limited and Crust Energy Limited to commit the fraud.

Sule Lamido, a former governor of Jigawa State, was arraigned along with his two sons - Aminu Sule Lamido and Mustapha Sule Lamido, Aminu Wada Abubakar Batholomew Darlington Agoha, before Justice Adeniyi Ademola of the Federal High Court, Abuja, on a 27-count amended charge bordering on corruption and money laundering. They are alleged to have used Bamaina Holdings Limited, Bamaina Company Nigeria Limited, Bamaina Aluminium Limited and Speeds International Limited to perpetrate the alleged fraud.



Ikedi Ohakim, a former governor of Imo State, was arraigned on alleged fraudulent practices before Justice Ademola Adeniyi of a Federal High Court, Abuja. He was alleged to have made a cash payment to the tune of \$2, 290,000.00 (about N270,000,000.00) for the purchase of a property at Plot Number 1098 Cadastral Zone A04, Asokoro District, otherwise known as Number 60, Kwame Nkurumah Street, Asokoro in Abuja. The amount is above the threshold approved for an individual, going by the provisions of Section 1 of the Money Laundering (Prohibition) Act 2004. The former governor is also accused of deliberately neglecting to disclose all his assets in the declaration submitted to the EFCC.




Gabriel Suswan, a former governor of Benue State was arraigned along with his finance commissioner, Omodachi Okolobia, before Justice A. R. Mohammed of the Federal High Court, Abuja on a nine-count charge of conspiracy, bribery, abuse of office and obtaining by false pretence. Suswan, in connivance with Okolobia allegedly diverted proceeds of the sale of shares owned by the Benue State government and Benue Investment and Property Company Limited for personal use.





Stephen Oronsaye, a former Head of Service, HoS, was arraigned along with Osarenkhoe Afe, Fredrick Hamilton Global Services Limited, Cluster Logistic Limited, Kangolo Dynamic Cleaning Limited and Drew Investment and Construction Company Limited on a 35count charge bordering on stealing and obtaining money by false pretence to the tune of N2 billion.
