
FROM THE SHELVES

he edition focused on the varied strategies being employed by the EFCC in executing its anti-corruption crusade, beyond the prosecution of fraudsters and politically exposed persons.

Particularly showcased in it, was the anti-graft agency's drama, *Road to Success*, which took about four days to shoot at various locations in Abuja (including the Government Secondary School, Jabi). It aimed at sensitizing the youths and the public in general, on the ills of corruption, with a special focus on examination malpractice and advance fee fraud.

Other crime prevention tools, included the EFCC's Inter-Faith Anti-Corruption Preaching/Teaching Manuals, which contain scriptural references, illustrations and teaching aids drawn from the Bible and the Quran, and the maiden edition of Red Alert on Scam - a 38page booklet tagged "wisdom in small packages", exposing the antics of fraudsters engaged in scams such as E-Commerce/Card Fraud, Wonder Bank/Ponzi Schemes, Romance & Dating Scam, Employment Scam, Identity Theft/Phishing Scam, Contract Scam/Funds Transfer, Inheritance Scam, Charity Scam, Juju Scam, Lottery Scam, Crude Oil/Mineral Resources Sales Scam, Scholarship Scam, Auction/Product Scam, Emergency Scam, Immigration/Visa Scam, and Local Purchase Order Scam.



Perspectives

- When you stay as a governor for eight years or [you're] a 'big' man for many years, there is no way you can account for every kobo. So if anybody wants to investigate you thoroughly, he will find a fault here and there." Bukar Abba Ibrahim, ex-Yobe State governor, and a serving senator gives excuse for his fellow members of the National Assembly, under investigation and prosecution by the EFCC.
- degeneration [that Nigeria] has [descended into], especially at the leadership level. The proposal is [no doubt] a way of legitimising corruption, because you are telling people to loot and declare part of the loot, then they are set free. This is not good for development and the fight against corruption." Balarabe Musa, a former Kaduna State governor, on the Economic Amnesty Bill, which seeks amnesty for treasury looters as long as they refund 70 percent of stolen funds.
- The bill is immoral, dangerous, discriminatory, illegal and unconstitutional. It is designed to shield looters of our commonwealth alone from prosecution [and is] meant to legitimise 'official' corruption and impunity in the country. If the bill is signed into law, all criminals who have been convicted and jailed for fraud, stealing, kidnapping and armed robbery are automatically entitled to similar amnesty and pardon." Femi Falana, SAN, human rights activist, opposing the proposed bill.
- We are not in support of a bill that will make a sinner go free. [It] must have been sponsored by looters [and] would amount to cheating for those who decided not to commit crime. At the end, it will still be victory for corruption and that is not good for the development of Nigeria." Debo Adeniran, Chairman, Centre for Anti-Corruption and Open Leadership, on why the bill should not see the light of day.

ompliance officers of banks in Benin zone which comprises Edo, Delta, Ondo and Anambra states have been warned not to ignore any "Place No Debit" order placed on accounts of suspects under EFCC's investigation, or face the music.

The warning, according to Yakubu, became imperative due to increasing instances of bank officials ignoring such

orders placed on accounts with suspicious transactions.

At a meeting with the officers of the bank, which held at the EFCC's Benin office, July 6, he noted that the banking sector was key to success of the antigraft agency.

"Corruption is a cankerworm that is threatening our existence as a nation," he said. "The earlier we join hands to deal with it, the better for us all."

ith protest banners reading "Care for human life and happiness is good governance", and "Mr. Governor, fulfil your 2017 May Day promises to Edo pensioners", the retirees defied the scorching sun and took their cries to the EFCC, July 12.

G.O. Osemwenkha, who led his coaged men and women to the Edo office of the anti-graft agency, lamented that "we have been turned into beggars and destitute elders, as the state government, despite receiving N11.38 billion and N12.18 billion bailout funds from

the federal government, has refused to pay us our outstanding pension".

"We bring our cry to you today, and request that the EFCC investigates how the state government spent the money," Osemwenkha said.

Yakubu commended them for their civil action, noting that: "your request will be taken to the appropriate authority, because it is the right of every civil servant who retires without blemish, to be paid his or her pension".

LAGOS

ne hundred and thirteen convictions, according to Ibrahim Magu, the EFCC boss, were secured by the agency between January and June 2017.

PORT HARCOURT

Monkey Business



ine men suspected to be oil thieves and pipeline vandals, are currently cooling their heels at the detention facility of the EFCC's Port Harcourt office, while investigation into their nefarious activity continues.

The men - Tony Edumesaro, Gbenga Obebe, Lucky Oshogbon, Erete Moses, Stephen Peters, Raphael Peters, Gillis Ibinabo, Ikechi Nwanyanwu and Ernest Iyalla, who were onboard the MT Lady Swithin vessel, were arrested by the Nigerian Navy, January 13.

Commanding officer of the team that arrested them, Captain S.W. Olorundare, said that they were caught with 300,000 litres of petroleum products along the Calabar offshore, and are believed to be operating without licence.

Mama Tears




or wasting the time of the court, and withdrawing a suit she filed against the EFCC, Patience, wife of former president, Goodluck Jonathan, was fined N50.000 by the Port Harcourt Division of the Federal High Court, July 3.

She had in February, sued the EFCC asking for an "enforcement of my fundamental human rights to own property, fair hearing, human dignity, privacy, and freedom from discrimination", but later withdrew the suit.

The prosecution had described the action of the former First Ladv as "an abuse of court process", and asked for a cost of N500,000.

The presiding judge, Justice S. Seidu, subsequently struck out the suit, and penalised her as requested by the EFCC awarding the cost.

Anti-Graft Tigers



Prof. Bolaji Owasanoye, secretary, Presidential Advisory Committee Against Corruption, enlightened the cadets, which included Assistant Detective Inspectors and

Assistant Detective Superintendents, on "strategies and tactics to fight corruption, and asset seizure and management".

The three-week course, which held in July, also had in attendance, pioneer Chairman of the EFCC, Nuhu Ribadu, who charged them on how to "make a career in law enforcement, while winning the fight against economic and financial crimes".






Indee Loses Again

former Comptroller-General of the Nigeria Customs Service, Dikko Inde, on July 4, lost his bid to vacate an interim forfeiture order placed on 17 vehicles seized from him by the EFCC.

The Kaduna Division of the Federal High Court, presided over by Justice S.M. Shuaibu, dismissed his application as

lacking in merit. The anti-graft agency had on February 24 obtained an interim forfeiture order from the court, "pending conclusion of

investigation and determination of the case". The confiscated vehicles were uncovered on February 20, at a warehouse linked to him, located on Nnamdi Azikwe Street, Kaduna. They are suspected to be proceeds of crime.
