## A Worthy Ambassador

Pioneer chairman of the EFCC receives international recognition for landmark achievements overseeing early stages of the anti-graft agency's anti-corruption crusade

he ripples of the historic event, which took place in faraway Malaysia were soon felt on the shores of the African continent, indeed, Nigeria. Nuhu Ribadu, pioneer chairman of the Economic and Financial Crimes Commission, EFCC, shone like the star that he is, as the world stood still for him, as he received the coveted Global Lifetime Award for Anti-Corruption. Ribadu, joint winner with Leonardo McCarthy, former South African corruption crusader and a former Vice President of the World Bank, was on December 7, honoured at the Putrajaya International Convention Centre in Malaysia for his invaluable role in inspiring a new era of the anticorruption crusade in Nigeria. "This award is a tribute to persons around the world working to curb

corruption," he said. Ribadu, who was beside himself with joy and satisfaction, served as chairman of the EFCC, 2003 to 2007, overseeing the "teething" stages of the agency. He paid tribute to EFCC staff, "some of whom, paid the supreme price in the line of duty". "This award will no doubt boost the morale of corruption fighters who would come to realize that their job is not thankless, after all," he added. The award, administered by Doha, Qatar-based think tank, Rule of Law and Anti-Corruption Centre, ROLACC, celebrates corruption fighters, academics and campaigners across the world. It was instituted by the Sheikh Al Thani in support of the United Nation's anticorruption drive.



## **Profile in Excellence**

The EFCC gets a new secretary as the Senate confirms the president's nominee for the post



hree months after President
Muhammadu Buhari, nominated
Olanipekun Olukoyede as
Secretary for the Economic and Financial
Crimes Commission, EFCC, in a letter
dated September 10, 2018, the Senate
on November 28, 2018 finally confirmed
the appointment.

Olukoyede who until the time was the Chief of Staff to the EFCC Chair, Ibrahim Magu, replaced Emmanuel Aremo, whose five-year tenure expired in July 2018. The confirmation is in accordance with Section 2(3) of the EFCC Establishment Act 2004.

A seasoned lawyer with several years of experience, Olukoyede is a regulatory compliance consultant, who specializes in corporate intelligence and fraud management. He is a certified fraud examiner who has led and managed investigation and civil litigation of fraud and financial crimes in international development projects.

He is a widely traveled scholar who has attended a number of training programmes within and outside of Nigeria, focusing on fraud and corruption investigation. He also specializes in Anti-Corruption Research and Analysis, Corporate and Business Intelligence Gathering and Process.

He studied at the Lagos State
University, University of Lagos,
Institute of Arbitration ICC – Paris,
France and Harvard University
Kennedy School of Government
(Executive Education).
A member of the Fraud Advisory
Panel (UK) and also a member,
Federal Government Technical
Committee on the Repositioning
of the Nigerian Financial
Intelligence Unit, he was born in
Ikere-Ekiti, Ekiti State, on October
14, 1969.



## Rallying Youths Against Corruption in Africa

The 2018 Anti-Corruption Day may well be the most significant in history of celebrating the United Nations designated event, as it witnessed a unique selection of events to rally youths and Nigerians in general to collectively own the anti-corruption fight

unday, December 9, 2018 will remain a historic day in the annals of the anticorruption crusade in Nigeria, and indeed, Africa. The day, which the world over has been designated by the United Nations as the Anti-Corruption Day, witnessed a history convergence of youths from across the African continent, on Nigeria's Federal Capital Territory, Abuja.

The day witnessed the first-ever African Youths Congress Against Corruption, AYCAC, hosted by President Muhammadu Buhari, at the State House Conference Hall, Abuja. Buhari, who had in July 2017 being endorsed as the first African Union Anti-Corruption Champion, had expressed his desire to bring

together youths from across Africa, in order for them to form a united and energetic front in championing the corruption fight in their respective countries.

Declared the "Year of Combating Corruption - a Sustainable Path to Africa's Transformation", the 2018

African Youths Congress, which was

part of activities marking this year's Anti-Corruption Day, had in attendance young anti-corruption crusaders and participants from the five African regions and provided the youths the opportunity to deliberate on how to advance the corruption fight in their various countries. Buhari charged African youths to own the fight against corruption and effectively ensure that they hold their governments

This fight against corruption is for the young people of Africa to lead and to win. You must effectively ensure that our natural and mineral resources remain on the continent for job and welfare issues as well as affordable healthcare and quality education for our people," he said.

He expressed optimism that African youths will rise to the great task of ridding the continent of corrupt practices, stressing that: "African youths must remain at the front and centre of restoring traditional African values of probity, integrity, diligence and hard work."

He urged them to "drive the change" in order to effectively eliminate corruption.

He thereafter shared with them what he described as "the ABC of fighting corruption.

He said: "'A' stands for 'Action'. Let us all move from talk to action.

"'B' stands for 'Building Bridges'. The youths have a unique opportunity to spearhead the building of inter-generational and cross-sectional bridges in our various communities. Fighting corruption requires partnerships,

we are allies.

"'C' stands for 'Culture'. Let us cultivate in ourselves the African culture, the right attitude and mindset against corruption." Moussa Faki Mahamat. Chairperson of the African Union Commission, who spoke on "The Africa We Want", urged the vouths to see themselves as the leaders of tomorrow and to ensure that Africa becomes a role model continent for the fight against corruption. Geoffery Onyeama, Minister for Foreign Affairs, said the convening of the Congress was essential to the anti-corruption

crusade.

"Let us create synergies by all working together and all fighting collectively as a unit, in order to win this fight," he said. He charged them to "endeavor to demonstrate passion, to demonstrate zeal and fearlessness if this war is to be won".

"I urge you to reposition Africa, through grassroots sensitizations and education programmes especially among teenagers and young children," he added. Abubakar Malami, the Attorney General of the Federation and Minister of Justice, said that corruption had robbed Africa of sustainable development and transformation, stating that it was a breach of the human rights of Africans, which must be resisted.

"We must support the system to crack down on safe havens for corrupt assets, restrict

movement of looters or our commonwealth and advocate sanctions by professional bodies against transactional middlemen including lawyers, bankers, brokers and public officials, who facilitate illicit flows", Malami said.

Ibrahim Magu, the Acting Chairman of the Economic and Financial Crimes Commission, who spoke on behalf of anticorruption agencies in Nigeria, said that the demonstration of the political will to fight corruption by the President, should serve as an impetus for all and sundry to join the collective action.

"It has therefore, become imperative for all of us to come together and fight corruption to rescue our nation and the continent so we may secure the future of our teeming youth," he said.

While assuring the African youths that the EFCC will not betray the anti-corruption mandate given to it by the people, Magu said, "We will remain firm and resolute as we confront corruption boldly and courageously until all corrupt elements and their destructive practices are defeated. We must uphold Accountability above everything else in every aspect of our lives and particularly, when we are called to serve". Representative of the United Nations Office on Drugs and Crime, Oliver Stolpe, noted that anti-corruption was critical to countering organized crime,

human trafficking, the trafficking of illicit drugs, weapons, and natural resources.

"The UNODC is working with governments, the private sectors, civil societies, sports organizations, educators, citizens, and most importantly the youths to reject corruption, promote integrity and achieve the sustainable development goals. United against corruption, we can foster our culture of lawfulness, we can help build accountable and transparent institutions," he said.

#### **Ibadan**

Abdulrasheed Bawa, Head, EFCC Ibadan Office, led staff and members of the Civil Society Organizations, Non-Governmental Organizations, Trade Unions, Collaborating Agencies, Youth Corp members and the Press, for the anti-corruption walk. Speaking to journalists during the walk, Mailafia Yakubu, Head of Operations, called on all Nigerians to "take ownership of the fight against corruption in Nigeria as corruption was at the intersection of our development".

#### **Port Harcourt**

Nnaghe Obono Itam, Head, EFCC Port Harcourt Office, led staff of the Commission on the anticorruption walk, urging them to "rise up decisively to the task of fighting corruption, in order to save Nigerians from its harmful effects". Participants included members of the National Youth Service Corps, along with anti-corruption crusaders in the state.

#### Uvo

The anti-corruption walk in Uyo was organised in partnership with the Akwa Ibom's Anti-Corruption Network, under the Umbrella of the MacArthur Foundation. The walk commenced after a press briefing by Abdulkarim Chukkol, Head, EFCC Uyo Office.

Chukkol urged those present to take the fight against corruption seriously and use the media to create more awareness on the ills of corruption, and to expose corrupt practices so they can be dealt with and corrected. The walk, which lasted about two hours, covered major streets in Uyo and terminated at the Water Fountain on four-lanes.
