





HARVEST of Convictions

Despite legal shenanigans by defence counsel in courts, it is winning ways for the EFCC, as the anti-graft agency continues to blaze the trail, grabs big wins at Supreme Court, Court of Appeal, and High Courts across the country; secures 2,595 convictions as at September 23, 2022.

t is undoubtedly a remarkable achievement. Indeed, as at September 23, 2022, the Economic and Financial Crimes Commission, EFCC has secured a record-breaking 2,595 convictions, with the record set to be increased through conscientious investigation and prosecution before the end of the last quarter of the year, even as the anti-graft agency intensifies efforts geared towards ridding the country of economic and financial crimes.

The jaw-dropping harvest of convictions, which comes at a time when securing convictions in Nigerian courts doesn't come easy, according to the EFCC Chairman, Abdulrasheed Bawa, was made possible by the forthrightness and commitment of President Muhammadu Buhari to the fight against corruption.

"The political will provided by President Muhammadu Buhari is second to none," said Bawa, at the margins of the 77th Session of the United Nations General Assembly, UNGA, September

24, 2022.

He reiterated that the emergence of President Buhari as the winner of the 2015 presidential election, galvanized the necessary machinery aimed at tackling illicit financial flows and corruption in Nigeria. "We are working hand-inglove with the Court. We are all over the place trying to see that we eradicate economic and financial crimes through the court processes and other preventive measures that we have in place."

For Bawa, four factors are critical and indispensable when dealing with the naughty issue of illicit financial flows, which is a precursor to money laundering and financial crimes: "They are political will, necessary legal framework, capacity by those saddled with the responsibility of enforcing the required laws, and the fear of God" While using the international forum to showcase the strides made by the EFCC, Bawa applauded the machineries put in place by President Buhari to tackle corruption, including the implementation of the Treasury Single Account, TSA policy, the signing of various Executive Orders to deal with illicit enrichment, the

restructuring of the Corporate Affairs Commission, CAC to have a Beneficial Ownership Register of all companies in Nigeria, among others.

"The signing of the Money Laundering Prevention and Prohibition Act, 2022, Terrorism Prevention and Prohibition Act, 2022, and the Proceeds of Crime Act, 2022, are legal instruments aimed at strengthening the existing domestic measures in combating IFFs," he said, further commending the President's approval of \$10 million as take-off grant for the Special Control Unit against Money Laundering, SCUML, which by legal status is now effectively domiciled in the EFCC. The effects of Buhari's unflinching political will, according to Bawa, has greatly enhanced the performance of the EFCC, such that the 2,595 convictions secured as at September 23, 2022 - an improvement on the conviction record of 2,220 in 2021, 312 in 2018, and 195 in 2016, was made possible due to the conducive environment availed the agency by the President to operate.

Perhaps, more significant is the fact that the achievements in this regard, also includes high profile members of the society, who challenged their convictions at the highest court of the land, but lost. Indeed, recently the Supreme Court and the Court of Appeal ruled in favour of the



EFCC in fraud matters involving John Yakubu Yusuf, a former Assistant Director in the Police Pension Office who was prosecuted for an alleged N22.9 billion fraud; Tuoyo Omatsuli, a former Executive Director, Projects, Niger Delta Development Commission, NDDC, prosecuted for an alleged N3.6 billion fraud, and Peter Nwaoboshi, senator representing Delta North senatorial district at the National Assembly, prosecuted for an alleged N322 million fraud.

Below is a focus on some of the cases:

Clement Iloh Onubuogo

On May 5, 2022, the EFCC secured the conviction and sentencing of a former Permanent Secretary in the Ministry of Labour and Productivity, Clement Illoh, to 12 years imprisonment before Justice Babs Kuewumi of the Federal High Court sitting in Ikoyi, Lagos. Illoh was prosecuted by the EFCC on a three-count charge bordering on nondeclaration of assets to the tune of N97.3million. The EFCC had accused him of receiving funds to the tune of N65 million from the Subsidy Reinvestment and Empowerment Programme, SURE-P project contractors as kickbacks. In the course of his trial, he had changed his "not guilty" plea to "guilty". Justice Kuewumi sentenced him to four years on each of the counts to run

concurrently from October 10, 2019. The judge also ordered the forfeiture of the sum of N97, 300,613.44, \$139,575.50 and £10,121.52 respectively to the Federal Government of Nigeria, being proceeds of unlawful activities traced to him.

The EFCC had, on October 3, 2019, secured his conviction and sentencing to five years in prison over a N14.1 million fraud before Justice Oluwatoyin Taiwo of the Special Offences Court sitting in Ikeja, Lagos.

Fake 'General' Bolarinwa

On July 7, 2022 the EFCC secured the conviction and sentencing of Bolarinwa Abiodun, a fake Army General to seven years in prison on a 13-count charge bordering on obtaining money by false pretence, forgery of documents and possession of documents containing false pretence to the tune of N266, 500,000. He was tried before Justice Oluwatovin Taiwo of a Special Offences Court sitting in Ikeja, Lagos. The offences he committed were contrary to Section 1 (3) of the Advance Fee Fraud and Other Fraud Related Offences Act 2006; Section 363 of the Criminal Law of Lagos State 2015 and Section 6 of the Advance Fee Fraud and Other Related Offences

Act No 14 of 2006, respectively. He was prosecuted by the Lagos Zonal Command of the EFCC. He was accused of posing as a General in the Nigerian Army using the guise to make false representations to Kodef Clearing Resources, that the President, Muhammadu Buhari, had short-listed him and one other to be appointed as the Chief of Army Staff, COAS, and that he needed a short grant to "press and process the appointment." He succeeded in defrauding Kodef Clearing Resources.

Justice Taiwo held that: "The defendant went the length of involving a former president of this country, General Obasanjo and forged documents allegedly signed by the current president of this country, President Muhammadu Buhari. It is so sad that people like the defendant have given our beloved country a bad image.

"It is obvious that the defendant appears to be a very intelligent man, more is the pity that he could not put his ingenuity to better use. In the light of the seriousness







of this scam, and in order to send a clear message to all scammers, fraudsters and criminals, this court is prepared to protect the interest of Nigerians and the society at large.

"I therefore sentence the defendant to seven years imprisonment without an option of fine."

The Court also granted the prayers of the prosecution for the forfeiture of the four vehicles and the property in order to help the victim recover his money. He was also ordered to pay N20 million as restitution to the victim. His First Bank account was also ordered "closed forthwith".

Bad News for John Yusuf

On April 13, 2022, the Supreme Court affirmed the six-year sentence of John Yusuf who was arraigned on March 29, 2012 alongside Esai Dangabar, Atiku Abubakar Kigo, Ahmed Inuwa Wada, Veronica Ulonma Onyegbula and Sani Habila Zira before Justice Mohammed Talba then a judge of the Federal Capital Territory, FCT High Court, Gudu on 16 counts bordering on conspiracy and criminal breach of trust to the tune of N32 billion.

Alas, Justice Talba following the decision of Yusuf to enter into a plea

bargain, literally gave him a slap on the wrist as he sentenced him to two years in prison on each of the three counts with an option of fine of N250,000 on each count.

Subsequently, the EFCC appealed the ruling at the Court of Appeal and won. The Appellate Court held that the three counts - 17, 18 and 19 to which he pleaded guilty to, clearly stated that he

diverted to his personal use, an aggregate sum of N24 billion. While reinstating the six-year jail term, the Appellate Court dismissed the order for an option of fine, but instead ordered him to return N22.9 billion traced to him as the funds he looted.

However, peeved by the ruling, Yusuf proceeded to the Supreme Court where sadly for him, again the EFCC emerged triumphant on April 13, 2022, with the Apex Court affirming his six years sentence, as well as the order of the Court of Appeal that he should refund N22.9 billion to the coffers of the Federal Government.

It was the final bus-stop for Yusuf, who had been on the run since 2018 following the ruling of the Appellate Court that he must serve the six-year jail-term and refund N22.9 billion for conniving with other culprits to loot N32.7 billion Police Pension fund.

He was later arrested by the EFCC after which Justice Hussein Baba Yusuf of the FCT High Court in June 2020 issued a remand order to ensure that he began his jail-term at the Kuje Correctional Centre, Abuia.

The victory, no doubt, is not only for the EFCC, but more for the old men and women of the Nigeria Police who though toiled under the rain and the sun to

provide security for their fellow citizens serving their Fatherland, have in their old age been deprived of their pension - the worthy fruits of their years of labour.

Tuoyo Omatsuli's Pyrrhic Victory

On April 13, 2022, the EFCC secured a major victory in the N3.6 billion fraud trial of Tuoyo Omatsuli, a former Executive Director, Projects, Niger Delta Development Commission, NNDC, at the Court of Appeal, Lagos Division, as the appellate court upheld the EFCC's appeal against his November 11, 2020 acquittal by Justice Saliu Saidu of the Federal High Court, Ikoyi, Lagos. Omatsuli was being prosecuted by the EFCC before Justice Saidu alongside Francis Momoh, Don Parker Properties Limited and Building Associates Limited, on an amended 45-count charge bordering on conspiracy and money laundering. They were accused of conniving to disguise the origin of N3,645,000,000 which investigation showed was the proceeds of gratification and corrupt practices engaged in between August 2014 and September 2015.

They had all pleaded "not guilty" to the charges when they were arraigned on November 10, 2018.

Ruling in favour of the EFCC, the three-man panel of the Appellate Court, Lagos Division, led by Justice Peter Affem, upheld the appeal and dismissed the ruling of Justice Saidu discharging Omatsuli.

In the ruling delivered by Justice Festus Ogbuinya on behalf of the panel, their Lordships set aside the ruling of the lower court and ordered him to enter his defence.

The Appellate Court, however discharged him on counts 27, 28, and 29 of the 45 counts and further dismissed the applications of Momoh and Building Associates Limited seeking to set aside the ruling of the lower court, which held that they had a case to answer and described the appeal as "bereft of merit".

They were all ordered to go back to the lower court and open their defence.

Peter Nwaoboshi

On July 1, 2022, the Court of Appeal, Lagos Division, sentenced Peter Nwaoboshi, the Senator representing Delta North, to seven years in prison for money laundering. The court also ordered that two of the senator's firms be wound up.

The EFCC had arraigned Nwaoboshi and his two firms – Golden Touch Construction Project Ltd and Suiming Electrical Ltd — in 2018 before

Justice Mohammed Idris of the Federal High Court, Lagos, before his elevation to the Court of Appeal. They were then rearraigned before Justice Chukwujekwu Aneke on October 5, 2018. The EFCC accused him of perpetrating N322 million fraud in 2014.

Justice Aneke dismissed the charge, holding that the EFCC failed to prove the elements of the offences for which it charged the senator. The trial judge also discharged the companies on the same grounds.

However, convinced of its case, the EFCC approached the Appellate Court, where the decision of Justice Aneke was overturned and the senator convicted of the offence.

The higher court held that the EFCC proved the ingredients of the offence and so consequently found the defendants guilty as charged. The two companies were also ordered to be wound up.

Okey Nwosu

On June 8, 2022, the EFCC secured a major win in the conviction of Okey Nwosu, a former Managing Director of the defunct FinBank Plc, and Dayo Famoroti, as the Court of Appeal, sitting at Tafawa Balewa Square, Lagos, upheld their conviction as well as their three years jail-term.

The EFCC had on January 5, 2021 secured their conviction and sentencing before Justice Lateefa A. Okunnu of the

Lagos State High Court sitting in Ikeja, for an alleged N19.2 billion fraud.

The defendants, had however appealed their conviction and sentencing.

While dismissing their appeal and upholding their conviction and sentencing, the Appellate Court, reduced the restitution order from N18 billion to N10 billion on the grounds that the bank had recovered N8 billion.

The defendants were said to have perpetrated the fraud while they were directors of the bank.

Francis Atuche

On June 23, 2022, a three-man panel of the Court of Appeal, Lagos Division, upheld the conviction of Francis Atuche, a former Managing Director of the defunct Bank PHB Plc, and Ugo Anyanwu, the bank's former Chief Financial Officer.

The EFCC had on June 16, 2021 secured their conviction before Justice Lateefat Okunnu of the Lagos State High Court, Ikeja after a trial that lasted 10 years. However, they appealed the judgement.

The panel, comprising of Justices Sadiq Umar, Adebukola Banjoko and Kayode Bada, upheld the EFCC's arguments and unanimously dismissed the appeal. The Appellate Court clarified that Atuche's jail term was 12 years concurrently, rather than 120 years, handed down by the lower court, if calculated consecutively. The panel also reduced Anyanwu's jail-term from 10 years to eight years.

Mama Boko Haram

On June 14, 2022 the EFCC secured the conviction and sentencing of Aisha Alkali Wakil, (aka Mama Boko Haram) alongside Tahiru Saidu Daura and Prince Lawal Shoyode before Justice Aisha Kumaliya of the Borno State High Court, Maiduguri. The defendants were sentenced to five years imprisonment without option of fine.

They were prosecuted by the Maiduguri Zonal Command of the



judgment was the climax of a process that commenced on Monday, September 14, 2020 when the defendants were re-arraigned on a two-count charge of conspiracy and obtaining money by false pretence to the tune of N71,400,000 (Seventy-One Million, Four Hundred Thousand Naira only).

The convicts were accused that whilst being Chief Executive Officer, Programme Manager, and Country Director respectively of Complete Care and Aid Foundation (a non-governmental organisation), sometime in 2018 at Maiduguri, Borno State, with intent to defraud, induced one Saleh Ahmed Said of Shuad General Enterprises Ltd to deliver to them 3,000 bags of beans worth N71,400,000, under the false pretence of executing a

contract for the supply of same. The offence is contrary to Sections 1(1) (b) and 1(3) of the Advance Fee Fraud and Other Fraud Related Offences Act. 2006. Mama

2022 convicted alongside Tahiru Saidu Daura and Prince Lawal Shoyede on a three count charge of conspiracy and stealing to the tune of N66 million. The defendants as promoter and managers of a Non-governmental organization, Complete Care and Aids Foundation on September 7, 2018 induced one Ali Tijjani, and his company, AMTMAT Global Ventures to supply N51million worth of processed maize grain also known as "biski" for which they refused to pay. **AMTMAT Global Ventures further** processed and funded the trip of the trio to Morocco to the tune of N15 million, a cost they refused to defray.

In a separate charge, the EFCC on September 29, 2022 secured the conviction and sentencing of Mama Boko Haram alongside Tahiru Alhaji, Saidu

he Legal Practitioners' Privileges
Committee, LPPC, on September
29, 2022, announced the elevation
of two lawyers of the EFCC - Sylvanus
Tahir and Rotimi Oyedepo to the coveted
rank of Senior Advocate of Nigeria, SAN.
According to Hajo Bello, Chief Registrar
of the Supreme Court, who made the
public announcement, their elevation was
based on a decision reached at the
LPPC's 154th plenary session.

"The rank of a Senior Advocate of Nigeria, SAN is awarded as a mark of

excellence to members of the legal profession who have distinguished themselves as advocates and academics," Bello said, adding that the elitist list for this year included 62 lawyers made up of 53 legal practitioners and nine academics.

Tahir, who heads the Legal and Prosecution Unit at the EFCC Headquarters, Abuja, is renowned for securing the conviction of a former spokesperson of the Peoples Democratic Party, PDP, Olisa Metuh, and

prosecuting high profile cases. Resourceful, unassuming and versed in the pyrotechnics of law, he is a well-regarded prosecutor. He has also won cases at the Appeal Court and Supreme Court, one of which is the setting aside by the Abuja Division of the Court of Appeal on August 4, 2022, of the acquittal of former Chief of Air Staff, Air Marshal Mohammed Dikko Umar by a Federal High Court, Abuja of money laundering charge to the tune of N66 million.

Oyedepo, who heads the Chairman's Monitoring Unit, CMU, at the Lagos Zonal Command of the EFCC has also maintained his brilliance across all the courts of the land prosecuting high profile cases, involving a former First Lady, Patience Jonathan, and a former Minister of Petroleum Resources, Diezani Alison-Madueke, among many other PEPs in the society. He is also celebrated for securing the forfeiture of humongous sums of money from the seeming untouchables in the society.

An elated Abdulrasheed Bawa, EFCC Chairman, applauded the resolution of the LPPC to elevate the EFCC counsel.

"The LPPC acted rightly for recognizing the sterling qualities of the two prosecutors; their elevation was well-deserved," he said. The newly minted SANs will be sworn in on November 21, 2022.

he Nigeria Security and Civil Defence Corps, NSCDC has described the Forensics Laboratory of the EFCC as one of the best in Africa.

Head, Forensic and Psychological Services Unit of NSCDC, Tersoo Shapper, made the assertion during a visit to the EFCC Headquarters, Abuja, on September 13, 2022.

"It is a fact that the EFCC Forensics has come to stay, and I am not just



talking about this country, I know what you are doing and I can describe the EFCC forensics services as one of the best in Africa," he said. "We are

actually presenting ourselves to you as partners in this job and in areas that you know better."

ACJA Monitoring Committee Ranks EFCC's Medical Facility Best in Nigeria

he Administration of Criminal Justice Act, ACJA, Monitoring Committee, has ranked the medical facility available at the EFCC as the best in the law enforcement community in Nigeria.

Justice Mabel. S. Bello of the Federal High Court made the assertion on September 14, 2022 when she led a delegation of the Committee to the EFCC Headquarters, Abuja to inspect and evaluate the custodial and medical facilities available to suspected fraudsters in the custody of the antigraft agency.

She said: "In

terms of medical facilities accessible to suspects so far, that I have seen in the Federal Capital Territory, and generally in the country, I think the EFCC's medical facility ranks the best; it has a texture of international standard and it is quite remarkable.

"If I am to do a comparative analysis, I will adjudge EFCC's detention facility 80 per cent better than all the other facilities that I have visited.

"This detention centre did not bring tears to my eyes, I did not find too

Secretary to the Commission, Dr. George Ekpungu, who received the delegation, described the EFCC as a standard bearer in the administration of criminal justice in Nigeria.

"We have always kept to standard and I am sure when you visit our cell, you will be convinced with what I am saying. EFCC does not arrest and dump people in the cell, we only remand people on the order of the court, and if we have to arrest someone and keep, we do not keep beyond the stipulated detention period," he said.
